# COUNCIL MINUTES 

Washington, D.C.

## 04 January 2009 at 1:30 p.m.


#### Abstract

The Council of the Society met at 1:30 p.m. on Sunday, 04 January 2009, in the Marshall Ballroom North/East of the Marriott Wardman Park Hotel, 2660 Woodley Road NW, Washington, D.C., 20008.

These are the minutes of the meeting. Although several items were treated in Executive Session, all actions taken are reported in these minutes.


## I. AGENDA

## 1. Call to Order

### 1.1. Opening of the Meeting and Introductions

The meeting was called to order at 1:35 pm. President James G. Glimm, who presided throughout, called on members and guests to introduce themselves. Other members present were George E. ### 1.2. 2008 Council Elections

The Society conducted its annual elections in the fall of 2008. Except for the new members of the Nominating Committee, those elected will take office on February 1, 2009. The newly elected members of the Council, the Editorial Boards Committee, the Nominating Committee and the Board of Trustees are listed under Item 4.1.

### 1.3. Retiring Members

The terms of James G. Glimm as President, of Ruth M. Charney as Vice President, of Lesley M. Sibner as Associate Secretary, of William M. Goldman, Craig L. Huneke, Judy Anita Kennedy, Ken Ono and Judy L. Walker as Members at Large of the Council, and of Robert Guralnick on the Executive Committee will end on 31 January 2009. This will be their final Council meeting in their current positions (although Glimm, Charney, Guralnick and Huneke will continue to serve on the Council in other capacities). Acting upon the Secretary's request, the Council unanimously consented that he send thanks to each of them for sharing their wisdom with the Society and the Council and for their service to the mathematical community.

## 3. Consent Agenda

The item below was approved by consent. (Items on the Consent Agenda are considered approved, unless brought to the floor for discussion, in which case they must be approved in the ordinary manner.)

### 3.1. Advisory Board for Mathematics Research Communities

With support of the National Science Foundation, the Mathematics Research Communities is underway on a semi-permanent basis, and the $a d$ hoc Steering Committee should give way to a more permanent Advisory Board to oversee the program. The Secretary recommends approval of the following general description and charge

# Mathematics Research Communities Advisory Board 

## General Description

Committee is standing.
Term is three years.
Number of members is nine, appointed by the President.

## Charge

The Advisory Board (Steering Committee) provides advice and guidance to the AMS staff concerning the Mathematics Research Communities (MRC) program, currently funded by the National Science Foundation. Each summer the Advisory Board will determine the conferences for the following summer sessions by reviewing the applications received and (possibly) soliciting additional applications. The Advisory Board may also be asked to consider various policy questions regarding the MRC program that arise from time to time. The Advisory Board should update the Committee on the Profession
annually about the MRC program and any current policy discussions or concerns.

## 4. Reports of Boards and Standing Committees

### 4.1. Tellers' Report on the 2008 AMS Elections [Executive Session]

The Society conducted its annual elections in the fall of 2008.

### 4.1.1. Tellers' Report on the Elections of Officers

### 4.1.4. Tellers' Report on the AMS Fellows Program Proposal

The vote on the proposal was 2622 in favor, 1336 opposed ( $66.2 \%$ in favor, $33.8 \%$ opposed), less than the $2 / 3$ affirmative vote which would have assured implementation.

The Council approved the Tellers' reports, which appear as Attachment C.

### 4.2. Editorial Boards Committee [Executive Session]

The Editorial Boards Committee (EBC) recommended two key appointments.

### 4.2.1. Mathematical Surveys and Monographs Editorial Committee

Upon the advice of the EBC, the Council appointed RALPH S. COHEN (Stanford University) as Chair of the Mathematical Surveys and Monographs Editorial Committee for a four- year term (01 February 2009-31 January 2013).

### 4.2.2. Transactions and Memoirs Editorial Committee

Again acting upon the advice of the EBC, the Council reappointed ROBERT GURALNICK as Chair of the Transactions and Memoirs Editorial Committee for a four- year term (01 February 2009-31 January 2013).

### 4.3. Nominating Committee [Executive Session]

The Nominating Committee recommended the nominations of ERIC M. FRIEDLANDER (University of Southern California) and WILFRIED SCHMID (Harvard University) as candidates for President Elect for the 2009 Election. This would be for a one-year term, 01 February 2010-31 Jan 2011, followed by a two-year term as President and then by a one-year term as Immediate Past President. The Nominating Committee also recommended that John M. Franks (Northwestern University) be named to write the nominating article for Friedlander and Roger Howe (Yale University) to write the one for Schmid. The Council made these nominations of candidates and approved the suggested authors of nominating articles.

### 4.4. Executive Committee and Board of Trustees

The Executive Committee and Board of Trustees (ECBT) made recommendations concerning the reappointment of one Associate Secretary, the appointment of another, and a small increase in individual member dues.

### 4.4.1. Associate Secretary for the Western Section

The second term of MICHEL LAPIDUS as Associate Secretary for the Western Section will expire on 31 January 2010. The ECBT recommends reappointment for another two-year term (01 February 2010 31 January 2012). Council approved.

### 4.4.2. Associate Secretary for the Central Section

Susan Friedlander, the current Associate Secretary for the Central Section, has moved out of the section and is not a candidate for reappointment. The ECBT established a committee consisting of John Conway, Robert Daverman, chair, and Craig Huneke to search for a successor. Based on this committee's suggestion, the ECBT recommended the appointment of GEORGIA BENKART to that post for a two-year term, effective 01 February 2010 and ending 31 January 2012. The Council appointed her to the post.

### 4.4.3. Dues Levels for the 2010 Membership Year

Using principles adopted in 2005 and following advice from the AMS staff, the ECBT recommended that the 2009 dues for individual members be increased by $\$ 4$ above the 2009 level for the high dues rate. This would put the regular high dues at $\$ 168$ and the regular low dues at $\$ 126$. Also it was recommended that the cutoff between high dues and low dues be raised from $\$ 80,000$ to $\$ 85,000$. Council approved raising the high dues by $\$ 4$ and the recommended increase in high/low dues cutoff.

In light of the current economic crisis, Council also approved publishing the following explanatory paragraph about the dues process:

> After extensive review and discussion, the Board of Trustees and the Council of the AMS have reluctantly voted to increase the dues of individual members in accordance with the guidelines adopted by the Trustees in 2003. Ordinary low dues will increase from $\mathbf{\$ 1 2 3}$ to $\mathbf{\$ 1 2 6}$, and ordinary high dues from $\$ 164$ to $\$ 168$. All segments of the mathematics community -individuals, institutions and professional societies - are facing difficult times, and this small increase appears to be the best compromise. However, the AMS governing bodies will continue to monitor the impact of the economic crisis and will revisit options for the dues structure in 2010.

### 4.5. Committee on Education

The Committee on Education met in Washington, D.C., on 31 October - 01 November 2008. The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No 081205-006.

### 4.6. Committee on Meetings and Conferences

The Committee on Meetings and Conferences (CoMC) met in Chicago, Illinois, on 12 April 2008. The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081119-007. Katherine St. John, the committee chair, provided an oral report.

### 4.7. Committee on the Profession

The Committee on the Profession (CoProf) met in Chicago, Illinois, on 13 September 2008. The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081119-008. Craig Huneke, the committee chair, provided an oral report.

The committee also made four specific recommendations requiring Council action, which appear below.

### 4.7.1. Advisory statement concerning interviewing at the JMM

Some members have become concerned that interviews for employment are sometimes held in hotel rooms or suites at the Joint Mathematics Meetings. This can cause uneasiness or anxiety for applicants (especially for female applicants). CoProf recommended adoption of the following advisory statement:

The AMS strongly encourages use of the Employment Center venues for all professional interviews of prospective employees at society meetings. The use of personal hotel rooms is particularly discouraged.

The motion carried.

### 4.7.2. Advisory Board on Employment Services

The AMS offers four main employment services for the PhD job market: (1) EIMS job ads on the AMS website and in a paper journal, (2) the Mathjobs.org electronic job application system, (3) job ads in the Notices of the AMS, and (4) Employment Center in-person interviews at the Joint Mathematics Meetings. Policy issue sometimes arise when seeking to match these services with the needs of the community. To meet its charge of policy oversight in the area of employment services, CoProf recommended establishing a three-person advisory board, which would report to CoProf regularly about how the employment services of the AMS are meeting those needs, with the following general description and charge:

## Advisory Board on Employment Services

## General Description

Committee is Standing.
Term is three years.
Membership: 3 at large members, appointed by the President.

## Charge

The Committee provides advice and guidance to the AMS staff in the area of employment services for mathematical scientists and those who hire them. Responsibilities include immediate attention to various policy questions that may arise from time to time, as well as a long-term view of the needs of the community, and the adequacy of AMS programs to meet those needs. The Advisory Board should update the Committee on the Profession annually about the state of AMS employment services and any current policy discussions or concerns.

The Council approved establishing this Advisory Board, with the given general description and charge.

### 4.7.3. Library Committee Charge

At its Spring 2007 meeting some members of the Committee on Committees remarked that charges to several AMS committee were unclear and might be out of date. CoProf appointed a subcommittee to review and possibly revise the AMS Library Committee charge. As an outcome of the process, CoProf recommended adoption of the following revised charge to the Library Committee.

The Library Committee considers the use by mathematicians of all the various resources found in mathematics libraries in Canada and the United States. It periodically collects and maintains authoritative data on those libraries, and it provides advice about the questions to be addressed when library surveys are conducted. It studies and articulates the needs and concerns of mathematicians about their use of both print and electronic information. It monitors problems in libraries and fosters dialog between mathematicians and librarians on issues concerning the dissemination and preservation of research. It supports librarians in their efforts to build and maintain better mathematics libraries and to provide ready access to information.

The motion carried.

### 4.7.4. Exemplary Program Award Selection Committee

The AMS has received a gift from an anonymous donor that endows this prize and allows for an annual prize amount of $\$ 5,000$. Co Prof recommended that Council approve this change in prize amount (and the corresponding change in the general description of the prize selection committee, reflecting an increase in the prize amount from $\$ 1200$ to $\$ 5000$ ). The Council approved the change in prize amount.

### 4.8. Committee on Publications

The Committee on Publications (CPub) met in Chicago on 12-13 September 2008. Among other activities, it conducted a review of the AMS Book Program. The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081204-009. Ken Ono, the committee chair, provided an oral report.

### 4.8.1. Pure and Applied Undergraduate Texts Editorial Committee

The Committee on Publications also unanimously recommended the creation of a new AMS undergraduate textbook series to the Council. This series will be devoted to textbooks for undergraduate post-calculus courses in pure and applied mathematics taught in colleges and universities in the US and abroad. The recently acquired titles from Cengage Learning, Inc., as approved by the ECBT in May 2008, will serve as a foundation for this new series. The committee would have the following general description and charge.

# Pure and Applied Undergraduate Texts Editorial Committee 

## General Description

- Committee is standing
- Number of members is four
- Term is four years


## Charge

This Editorial Committee is charged with selecting projects for publication that would be appropriate as upper level (post-calculus) undergraduate level textbooks in pure and applied mathematics. The Committee is encouraged to look favorably on recommendations from other editorial committees of the Society, but is ultimately responsible for the actual selection of books in the series.

The principal function of a book editorial committee is to decide the appropriateness of proposed book projects for publication. Because the AMS is aggressively competing with other mathematics publishers, it is extremely important that the committee makes decisions in a timely manner, usually within several weeks and always within 3 months' time.

The Committee may often seek the advice of one or more outside experts in order to facilitate its decision process, but this is not always necessary. The AMS Acquisitions Staff is charged to assist and support the committee in any way possible, including preparation and distribution of necessary materials and communication with outside experts suggested by the committee.

Council approved the general description and charge.

### 4.8.2. Recommendation on Author Charges

At its September 2008 meeting, the Committee on Publications discussed various open access models for journals and the implications for mathematics. There was particular concern for author-pay models of open access, which often assume that publication fees can be made a part of research grants. This is not the case for many mathematics research papers.

The committee discussed a statement to express the general concern about this situation and charged a subcommittee to refine that statement for consideration by the Council. The statement recommended to the Council (by the subcommittee, not by CPub itself) for approval was:

The American Mathematical Society strongly endorses the principle that a paper in the mathematical sciences should have the opportunity to be evaluated and possibly published without regard to the financial circumstances of its authors. For this reason, the AMS does not charge authors any fees for publication in its journals.

The Council approved the statement.

### 4.9. Committee on Science Policy

The Committee on Science Policy (CSP) met in Washington, D.C., on 17-18 April 2008. The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 080324010. Ronald Stern, the committee chair, provided an oral report.

### 4.10. Mathematical Reviews Editorial Committee

The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081015-011. Jonathan Hall, the committee chair, provided an oral report.

### 4.11. Arnold Ross Lectures Committee

The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081119-012.

### 4.12. Human Rights Short Course Committee

The annual report of this committee has been filed in the AMS Committee Report Book as Committee Report No. 081203-013.

### 4.13. Short Course Committee

## 5. Old Business

### 5.1. AMS Fellows Program

The vote by the membership on the proposed Fellows Program fell just short of the $2 / 3$ majority that would have assured implementation. The Executive Committee called for discussion at this Council Meeting about the repercussions of this vote by the membership.

After extensive discussion, no action was taken concerning when the issue might be raised again. (There was widespread sentiment that the issue should be allowed to rest for a few years, with no consensus about the specific length of the rest period.)

Amid the general discussion, a particular concern expressed about the current proposal was that, once the program was underway, half of those nominated as Fellows would not be elected, and their defeat was likely to be quite public. It was moved and seconded to appoint a committee charged with recommending changes to the program, particularly with respect to the process for naming fellows. That motion carried.

## 6. New Business

### 6.1. Chief Editor for the Notices of the American Mathematical Society [Executive Session]

The second term of Andy R. Magid as Chief Editor of the Notices will end December 31, 2009. Under procedures established in 2006, a committee consisting of the President, Secretary, Executive Director, and two members of the Council (appointed by the President) should make a recommendation to the Council about a chief editor for the Notices for the next term. A committee consisting of Robert Daverman, John Ewing (chair), James Glimm, Rebecca Goldin and Judy Kennedy, which deliberated in the summer and fall of 2008, unanimously recommended that STEVEN G. KRANTZ be appointed as Chief Editor of the Notices for the term 2010-2012. The Council made the appointment of Krantz as the next editor.

### 6.2. Executive Director of the AMS [Executive Session]

In early July 2008 John Ewing announced to AMS Officers and the Board of Trustees his intention of resigning from his post as Executive Director either at the end of 2008 or, as was his preference, immediately after the Joint Mathematics Meetings in January 2009. A search committee was formed very quickly, consisting of the Board of Trustees, the President Elect and the Secretary. The Search Committee did its due diligence, contacting many people, seeking suggestions, twisting arms, seeking candidates to apply by an October 15 deadline. Shortly after the deadline passed, the committee narrowed the applicant pool to a short list, with whom it conducted phone interviews in late October. Based on those phone interviews it narrowed the list once again and then conducted face-to-face interviews with the remaining candidates. On November 17, 2009, a day after the final in-person interview, the Search Committee (George Andrews, John Conway, Robert Daverman, John Franks, Eric Friedlander, James Glimm, Linda Keen, Karen Vogtmann and Carol Wood) met by phone and identified its top choice for successor to John Ewing: DONALD E. MCCLURE, currently a professor of applied mathematics at Brown University and the Associate Treasurer of the AMS. On Saturday, November 22, 2008, the chair of the Search Committee met with the Executive Committee of the Council, which unanimously endorsed the choice of McClure for the position.

AMS Bylaws call for the Board to seek the consent of the Council when appointing an Executive Editor. The Council ratified the selection of Donald McClure as the next Executive Director of the American Mathematical Society. This appointment will be effective immediately after the 2009 Joint Mathematics Meetings.

## 7. Announcements, Information and Record

### 7.1. Budget

The Board of Trustees adopted the budget for 2009 as presented at its meeting on 22 November 2008.

### 7.2. Executive Committee Actions

In December the Executive Committee approved a recommendation of the Chief Editor of the Bulletin, Susan Friedlander, to appoint David Benson as an Associate Editor for Bulletin Articles. The term is 01 February 2009-31 January 2012.

### 7.3. Next Council Meeting

The next AMS Council Meeting will be held Saturday, 18 April 2009, in Chicago, Illinois, starting at noon with a working lunch. As usual, a significant component of the Council meeting will be the actual nomination of candidates for election to AMS offices, as proposed by the Nominating Committee. In addition, there will be a Council discussion period about Employment Prospects in the New Economy. It will concentrate on what the AMS can do to help young mathematicians improve their employment chances. Previous discussion topics were: the role of the AMS in graduate and post-doctoral mathematics education (2002, 2003); membership, specifically, retention of nominee members and providing access to the Notices at certain periods as a members-only benefit (2004); the composition of the Council itself (2005), steps the AMS might take to better engage young mathematicians into the profession (2006), what the AMS is doing concerning mathematics education, broadly considered (2007), and International Programs and the AMS (2008).

## 8. Adjournment

The meeting adjourned at $5: 18 \mathrm{pm}$.
