Book Reviews are accepted for publication by invitation only. Unsolicited manuscripts will not be considered.

Editorial Information

As of November 1, 1992, the backlog for this journal was approximately 2 issues. This estimate is the result of dividing the number of manuscripts for this journal in the Providence office that have not yet gone to the printer on the above date by the average number of articles per issue over the previous twelve months.

A Copyright Transfer Agreement is required before a paper will be published in this journal. By submitting a paper to this journal, authors certify that the manuscript has not been submitted to nor is it under consideration for publication by another journal, conference proceedings, or similar publication.

Information to Authors

For Research-Expository Papers and Research Announcements, the first page must consist of a *descriptive title*, followed by an *abstract* that summarizes the article in language suitable for workers in the general field (algebra, analysis, etc.). The *descriptive title* should be short but informative; useless or vague phrases such as "some remarks about" or "concerning" should be avoided. The *abstract* should be a brief technical description of the new material. Then, for Research Announcements, there should be an introductory section addressed to nonexperts describing the motivation, background, and significance of the results announced. Following the statement of results, there should be a sketch of proofs that may be addressed to experts. An announcement should not exceed 7 published pages, and preferably not exceed 5 pages. For Research-Expository Papers and Research Announcements, included with the footnotes to the paper, there should be the 1991 *Mathematics Subject Classification* representing the primary and secondary subjects of the article. This may be followed by a list of *key words and phrases* describing the subject matter of the article and taken from it. A list of the numbers may be found in the annual index of *Mathematical Reviews*, published with the December issue starting in 1990, as

Remarks on Research Announcements

The circulation of the *Bulletin* is larger by an order of magnitude than that of most research mathematics journals; it is received by essentially every member of the Society. Space is limited to around 40 Announcements each year. The following facts largely determine the qualities looked for in an Announcement:

The results should be, roughly speaking, among the 40 most significant or interesting achievements in mathematics in the year. The paper should contain background material for nonexperts that indicates why the results are significant and interesting.

Address the paper to as wide an audience as possible, not just to experts. Strive for clarity and precision. Avoid jargon and introduce the terminology necessary to understand the main results. If space considerations prevent a full development, delineate clearly what is not being explained and provide references. The proof sketch can be more technical.

Ask a colleague to review your manuscript before you submit it. Even better, ask two colleagues, one whose work is close to yours, one whose work is farther away. (If you can't get two people you know to read your work before it is published, how many will want to read it after?) Ask for suggestions on how to improve the readability.

An abstract and the 1991 *Mathematics Subject Classification* are required. Papers submitted without these will be delayed.

Authors are encouraged to supply electronic addresses when available. These will be printed after the postal address at the end of each article.

Electronically-prepared manuscripts. The AMS encourages submission of electronically-prepared manuscripts in $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$ because properly prepared electronic manuscripts save the author proofreading time and move more quickly through the production process. To this end, the Society has prepared “preprint” style files, specifically the amsppt style of $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ and the amsart style of $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$, which will simplify the work of authors and of the production staff. Those authors who make use of these style files from the beginning of the writing process will further reduce their own effort.

Guidelines for Preparing Electronic Manuscripts provide additional assistance and are available for use with either $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$. Authors with FTP access may obtain these *Guidelines* from the Society’s Internet node e-MATH.ams.org (130.44.1.100). For those without FTP access they can be obtained free of charge from the e-mail address guide-elec@math.ams.org (Internet) or from the Publications Department, P. O. Box 6248, Providence, RI 02940-6248. When requesting *Guidelines*, please specify which version you want.

Electronic manuscripts should be sent to the Providence office only after the paper has been accepted for publication. Please send electronically-prepared manuscript files via e-mail to pub-submit@math.ams.org (Internet) or on diskettes to the Publications Department at the address listed above. When submitting electronic manuscripts, please be sure to include a message indicating in which publication the paper has been accepted.

Copies of the paper should be sent directly to the appropriate Editor, and the author should keep one copy. At that time, authors should indicate if the paper has been prepared using $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$. For Research-Expository papers, two copies of the manuscript should be submitted to Professor Richard S. Palais, Department of Mathematics, Brandeis University, Waltham, MA 02154-9110. For Research Announcements, four copies of the manuscript should be submitted to Professor Frank Quinn, Department of Mathematics, Virginia Tech, Blacksburg, VA 24061-0123. Research Announcements can also be submitted electronically in the standard $\text{T}\mathcal{E}\mathcal{X}$ formats to bams@vtmath.math.vt.edu. The *Manual for Authors of Mathematical Papers* should be consulted for symbols and style conventions.
