Note:

The one female Assistant Professor whose full-time academic-year salary is reported between \$55,000 and \$59,999 is the one on a 11-12 month appointment. Her salary for the appointment is \$70,000, but this figure is multiplied by 0.8 to reach the equivalent academic-year salary of \$56,000 reported on this form.

The one Full Professor whose full-time academic-year salary is reported between \$65,000 and \$69,999 is half-time (0.5 FTE) in the department but full-time at the university.
