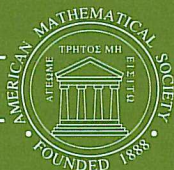

Editorial Information

As of July 31, 1996, the backlog for this journal was approximately 0 issues. This estimate is the result of dividing the number of manuscripts for this journal in the Providence office that have not yet gone to the printer on the above date by the average number of articles per issue over the previous twelve months, reduced by the number of issues published in four months (the time necessary for editing and composing a typical issue).

A Consent to Publish and Copyright Agreement is required before a paper will be published in this journal. By submitting a paper to this journal, authors certify that the results have not been submitted to nor are they under consideration for publication by another journal, conference proceedings, or similar publication.

Information for Authors

Initial submission. Copies of the paper should be sent directly to the appropriate Editor, and the author should keep one copy. For Research-Expository Surveys two copies of the manuscript should be submitted to Professor David Eisenbud, Department of Mathematics, Brandeis University, Waltham, MA 02254-9110. For Research Reports, four copies of the manuscript should be submitted to Professor Haynes R. Miller, Room 2-237, Massachusetts Institute of Technology, Cambridge, MA 02139-4307. Research Reports can also be submitted electronically in $\mathcal{A}\mathcal{M}\mathcal{S}$ - $\mathcal{T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}$ - $\mathcal{L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$ to bams@math.mit.edu.

For Research-Expository Surveys and Research Reports, the first page must consist of a *descriptive title*, followed by an *abstract* that summarizes the article in language suitable for workers in the general field (algebra, analysis, etc.). The *descriptive title* should be short but informative; useless or vague phrases such as “some remarks about” or “concerning” should be avoided. The *abstract* should be a brief technical description of the new material. Then, for Research Reports there should be an introductory section addressed to nonexperts describing the motivation, background, and significance of the results announced. Following the statement of results, there should be a sketch of proofs that may be addressed to experts. Included with the footnotes in each paper, there should be the 1991 *Mathematics Subject Classification* representing the primary and secondary subjects of

the article. This may be followed by a list of *key words and phrases* describing the subject matter of the article and taken from it. A list of classifications may be found in the annual index of *Mathematical Reviews*, published with the December issue starting in 1990. Journal abbreviations used in bibliographies are also listed in the latest *Mathematical Reviews* annual index. The classifications and the journal abbreviations are accessible from e-MATH via the World Wide Web through the URL <http://www.ams.org/committee/publications/mr-info.html> or via FTP to [e-math.ams.org](ftp://e-math.ams.org) (login as `anonymous` and enter username as password). The classifications are available as a browsable list, and the journal abbreviations are available through a search tool. Authors are encouraged to supply electronic addresses when available. These will be printed after the postal address at the end of each article.

Electronically prepared manuscripts. The AMS encourages submission of electronically prepared manuscripts, with a strong preference for $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX submissions. To this end, the Society has prepared $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX author packages for each AMS publication. Author packages include instructions for preparing electronic manuscripts, the *AMS Author Handbook*, samples, and a style file that generates the particular design specifications of that publication series. Articles properly prepared using the $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX style file automatically provide hypertext linking to the bibliography and other elements of the article for searching electronically on the World Wide Web. Because linking must often be added manually to submissions in other forms of \TeX , using $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX also reduces the amount of technical intervention once the files are received by the AMS. This results in fewer errors in processing and saves the author proofreading time. $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX papers also move more efficiently through the production stream, helping to minimize publishing costs.

$\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX is the highly preferred format of \TeX , but author packages are also available in $\mathcal{A}\mathcal{M}\mathcal{S}$ - \TeX . Those authors who make use of these style files from the beginning of the writing process will further reduce their own efforts. Electronically submitted manuscripts prepared in \LaTeX or plain \TeX are normally not acceptable due to the high amount of technical time required to insure that the file will run properly through the AMS in-house production system. \LaTeX users will find that $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX is the same as \LaTeX with additional commands to simplify the typesetting of mathematics, and users of plain \TeX should have little difficulty learning $\mathcal{A}\mathcal{M}\mathcal{S}$ - \TeX .

Authors may retrieve an author package from e-MATH via the World Wide Web through the URL <http://www.ams.org/tex/> or via FTP to [e-math.ams.org](ftp://e-math.ams.org) (login as `anonymous` and enter username as password). The author package can also be obtained free of charge by sending e-mail to pub@ams.org (Internet) or from the Publication Division, American Mathematical Society, P.O. Box 6248, Providence, RI 02940-6248. When requesting an author package, please specify $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX or $\mathcal{A}\mathcal{M}\mathcal{S}$ - \TeX , Macintosh or IBM (3.5) format, and the publication in which your paper will appear. Please be sure to include your complete mailing address.

At the time of submission, authors should indicate if the paper has been prepared using $\mathcal{A}\mathcal{M}\mathcal{S}$ - \LaTeX or $\mathcal{A}\mathcal{M}\mathcal{S}$ - \TeX and provide the Editor with a paper manuscript that matches the electronic manuscript. The final version of the electronic manuscript should be sent to the Providence office immediately after the paper has been accepted for publication. The author should also send the final version of the

paper manuscript to the Editor, who will forward a copy to the Providence office. Editors will require authors to send their electronically prepared manuscripts to the Providence office in a timely fashion. Electronically prepared manuscripts can be sent via e-mail to pub-submit@ams.org (Internet) or on diskette to the Electronic Prepress Department, American Mathematical Society, P.O. Box 6248, Providence, RI 02940-6248. When submitting an electronic manuscript, please be sure to include a message indicating in which publication the paper has been accepted. No corrections will be accepted electronically. Authors must mark their changes on their proof copies and return them to the Providence office. Complete instructions on how to submit files are included in the author package.

Electronic graphics. Figures may be submitted to the AMS in an electronic format. The AMS recommends that graphics created electronically be saved in Encapsulated PostScript (EPS) format. This includes graphics originated via a graphics application as well as scanned photographs or other computer-generated images.

If the graphics package used does not support EPS output, the graphics file should be saved in one of the standard graphics formats—such as TIFF, PICT, GIF, etc.—rather than in an application-dependent format. Graphics files submitted in an application-dependent format are not likely to be used. No matter what method was used to produce the graphic, it is necessary to provide a paper copy to the AMS.

Authors using graphics packages for the creation of electronic art should also avoid the use of any lines thinner than 0.5 points in width. Many graphics packages allow the user to specify a “hairline” for a very thin line. Hairlines often look acceptable when proofed on a typical laser printer. However, when produced on a high-resolution laser imagesetter, hairlines become nearly invisible and will be lost entirely in the final printing process.

Screens should be set to values between 15% and 85%. Screens which fall outside of this range are too light or too dark to print correctly.

T_EX files available. Beginning with the January 1992 issue of the *Bulletin* and the January 1996 issues of *Transactions*, *Proceedings*, *Mathematics of Computation*, and the *Journal of the AMS*, T_EX files can be downloaded from e-MATH, starting from URL <http://www.ams.org/journals/>. Authors without Web access may request their files at the address given below after the article has been published. For *Bulletin* papers published in 1987 through 1991 and for *Transactions*, *Proceedings*, *Mathematics of Computation*, and the *Journal of the AMS* papers published in 1987 through 1995, T_EX files are available upon request for authors without Web access by sending e-mail to file-request@ams.org or by contacting the Electronic Prepress Department, American Mathematical Society, P.O. Box 6248, Providence, RI 02940-6248. The request should include the title of the paper, the name(s) of the author(s), the name of the publication in which the paper has or will appear, and the volume and issue numbers if known. The T_EX file will be sent to the author making the request after the article goes to the printer. If the requestor can receive Internet e-mail, please include the e-mail address to which the file should be sent. Otherwise please indicate a diskette format and postal address to which a disk should be mailed. **Note:** Because T_EX production at the AMS sometimes requires extra fonts and macros that are not yet publicly available, T_EX files cannot be guaranteed to run through the author’s version of T_EX without errors. The AMS

regrets that it cannot provide support to eliminate such errors in the author's \TeX environment.

Research-Expository Surveys

This section is intended for reasonably broad expository surveys of a currently active area of mathematical research. To stress this fact, the name of the section has been changed from "Research-Expository Papers" to "Research-Expository Surveys". The level of exposition is expected to be such that a graduate student—or a research mathematician from a remote area—will be able to read an article in order to get an overview of a subject. A well-written article will include motivating problems and examples, some indication of the historical development of the subject, and of course the results and open problems that make it an interesting and exciting area of mathematics. In most cases proofs should be at most briefly sketched, and there should be a good bibliography whose main aim should be helping those wishing to pursue the subject further. Usually Research-Expository Surveys will be at most 40 pages long.

Certain of the Society's Lecture Series, including the Gibbs Lectures, Colloquium Lectures, and Progress in Mathematics Lectures, traditionally appear in the Research-Expository Surveys, and those invited to give these lectures are informed of this tradition and of the above guidelines. Research-Expository Surveys are also frequently solicited by the Editorial Board, but unsolicited manuscripts are also encouraged; in particular, those invited to give invited hour addresses at meetings of the Society should consider writing up their lecture in a manner that meets the requirements of the preceding paragraph and submitting their manuscripts for consideration by the Editorial Board for the Research-Expository Surveys.

Research Reports

A Research Report is a timely, short (4–8 pages) report on a recent accomplishment in mathematical research. It should be written so as to be understandable by mathematicians who are not experts in the subject matter of the Report. The context giving significance to the research being reported on should be made clear, and the consequences or potential consequences should be described. Usually only the barest hint of the methods of proof should be given, although elements of the proof which are novel should be included. In any case, references should be given so that an interested reader can find the details. It is expected that Research Reports will frequently be written by specialists other than the individuals immediately involved in the research. Approximately twenty-four Reports will be published each year.

Research Reports are normally solicited by the Editor for Research Reports and the Board of Associate Editors. They cordially invite suggestions for topics and reporters. Unsolicited manuscripts, submitted to the Editor for Research Reports, will also be considered.
