### MEETINGS OF THE SOCIETY

This is the Semicentennial Celebration of the founding of the American Mathematical Society. A brief prospectus appeared in the Bulletin for September, 1937. There will be hour addresses by Professor R. C. Archibald on the history of the Society, by Dean G. D. Birkhoff on a general review of mathematics during the fifty years, and by Professors E. T.
