## INFORMATION FOR SUBSCRIBERS

Subscription prices for Volume 82 (1976) are list \$22.00, member \$11.00. The subscription price for members is included in the annual dues. Back number prices *per volume* for Volumes 1-55 (1894-1949) are list \$28.00, member \$21.00; Volumes 56-80 (1950-1974), list \$21.00, member \$15.75; Volume 81 (1975); list \$27.00, member \$20.25.

Back volumes of the BULLETIN are also available on 16 mm microfilm, either negative or positive, and may be mounted either on spools or in Eastman or 3M cartridges.
