INFORMATION FOR AUTHORS

Submission of Manuscripts. All manuscripts should be electronically prepared in $\mathcal{A}\mathcal{M}\mathcal{S}\text{-}\mathcal{L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$. A PDF file of the manuscript should be sent via email to the Managing Editor or to any member of the Editorial Board. Authors are encouraged to submit manuscripts written in English. An abstract of at least one complete sentence and at most 300 words is required for every paper. The *Journal of Algebraic Geometry* offers free worldwide access to the electronic abstracts. All author names must be in First-Middle-Surname order. A manuscript accepted for publication must be typeset by the author(s) in $\mathcal{A}\mathcal{M}\mathcal{S}\text{-}\mathcal{L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$.

Authors should supply email addresses if available and current postal addresses, along with their affiliations, on the last page of the manuscript. To help avoid delays in publication, authors are encouraged to send changes in postal and email addresses to jag-query@ams.org, especially before proof has been sent to authors. Articles are posted after proof is returned from authors and before appearing in an issue. Once an article is posted, author information, such as postal and email addresses, cannot be updated.

To eliminate unnecessary delay or difficulties in printing, authors may be guided by the book *Mathematics into Type*, updated edition, Amer. Math. Soc., 1999.

Footnotes, except a possible acknowledgment of assistance or financial support on the first page, should be avoided by being incorporated into the text, perhaps parenthetically.

References will be published as submitted. For the best presentation, the list of references must be submitted in alphabetical-chronological order; abbreviations of names of journals and references to books should follow the standard form established by Mathematical Reviews. Abbreviations used in bibliographies are accessible from www.ams.org/msnhtml/serials.pdf. The following references are two typical examples:

An $\mathcal{A}\mathcal{M}\mathcal{S}\text{-}\mathcal{L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$ author package has been prepared for the convenience of the author. The author package includes instructions for preparing electronic manuscripts, the *AMS Author Handbook*, samples, and a style file. Authors who make use of these style files from the beginning of the writing process will reduce their own effort. Please be sure to include your complete email address.

Immediately after a paper has been accepted for publication, the electronically prepared manuscripts (.tex files) should be submitted via the web at www.ams.org/submit-book-journal/, sent via email to pub-submit@ams.org, or sent on CD to the Electronic Prepress Department, American Mathematical Society, 201 Charles Street, Providence, RI 02904-2294 USA. When submitting electronic manuscripts via email or CD, please include a message indicating that the paper has been accepted for publication in the *Journal of Algebraic Geometry*. The author should also send one hard copy of the final version of the paper to the Managing Editor.

Proofs. Authors receive only one set of proofs for corrections and will be responsible for the expense of making excessive alterations to the original manuscript during the proof-reading. Authors will be responsible for adjustments made to artwork not provided in camera-ready form.

Offprints. Offprints are provided free of charge in electronic format. A downloadable and printable PDF version of the published article will be available on the AMS website at www.ams.org/myoffprints immediately following each issue's publication date.
