THIS JOURNAL is devoted entirely to research in pure and applied mathematics, and includes, in general, longer papers than those in the PROCEEDINGS.

PREPARATION OF THE MANUSCRIPT. All papers should be typewritten double-spaced, and two copies should be sent to the appropriate editor. The author should keep a complete copy.

FORM OF MANUSCRIPT. The first page should consist of a *descriptive title*, followed by an *abstract* which summarizes the article in language suitable for workers in the general field (algebra, analysis, etc.). The *descriptive title* should be short, but informative; useless or vague phrases such as "Some remarks about" or "concerning" should be avoided. Also avoid proper names unless mathematical usage associates them with the work. The *abstract* should be at least one complete sentence, and at most 300 words, with the upper limit primarily for longer papers. Included with the footnotes to your paper, but placed before the first footnote, there should be first the *AMS (MOS) subject classification numbers* representing the primary and secondary subjects of the article, which may be followed by a list of *key words and phrases* describing the subject matter of the article and taken from it. The *AMS (MOS) Subject Classification Scheme (1970)* with instructions for its use can be found as an appendix to *Mathematical Reviews, Index to Volume 39 (June 1970)*. See the June 1970 Notices for more details, as well as illustrative examples.

SUBMISSION OF MANUSCRIPT. See the inside back cover of this journal.

GALLEY PROOF. When a paper with more than one author has been accepted for publication, only one set of galley proof will be sent. Joint authors should, therefore, indicate on the original manuscript which of them should receive galley proof in the event that the manuscript is accepted for publication.

PUBLICATION CHARGES. The research journals of the American Mathematical Society carry a page charge of \$40.00 per page to help defray the cost of publication. This amount is charged to the institution or to a contract supporting the research reported in the published paper. The publication charge policy of the United States Federal Council for Science and Technology (FCST) is reported on page 112 of the February, 1975 issue of the NOTICES of the American Mathematical Society. In no case is the author personally responsible for paying the page charge, nor is acceptance of his paper for publication dependent upon payment of the page charge.

BACKLOG. 1300 pages. Two-thirds of the papers currently being accepted by the editors will be published in 16–18 months.
