

THIS JOURNAL is devoted entirely to research in pure and applied mathematics, and includes, in general, longer papers than those in the PROCEEDINGS.

PREPARATION OF THE MANUSCRIPT. All papers should be typewritten double-spaced, and two copies should be sent to the appropriate editor. The author should keep a complete copy.

FORM OF MANUSCRIPT. The first page should consist of a *descriptive title*, followed by an *abstract* which summarizes the article in language suitable for workers in the general field (algebra, analysis, etc.). The *descriptive title* should be short, but informative; useless or vague phrases such as "Some remarks about" or "concerning" should be avoided. Also avoid proper names unless mathematical usage associates them with the work. The *abstract* should be at least one complete sentence, and at most 300 words, with the upper limit primarily for longer papers. Included with the footnotes to your paper, but placed before the first footnote, there should be first the 1980 *Mathematics Subject Classification* representing the primary and secondary subjects of the article, which may be followed by a list of *key words and phrases* describing the subject matter of the article and taken from it. The 1980 *Mathematics Subject Classification* with instructions for its use can be found in the 1978 *Subject Index to Mathematical Reviews*.

SUBMISSION OF MANUSCRIPT. See the back of this journal.

COPYRIGHT TRANSFER AGREEMENT. The signing of a Copyright Transfer Agreement is a requirement for publication.

GALLEY PROOF. When a paper with more than one author has been accepted for publication, only one set of galley proof will be sent. Joint authors should, therefore, indicate on the original manuscript which of them should receive galley proof in the event that the manuscript is accepted for publication.

PUBLICATION CHARGES. The research journals of the American Mathematical Society carry a page charge of \$50.00 per page to help defray the cost of publication. The amount is charged to the institution or to a contract supporting the research reported in the published paper. The publication charge policy of the United States Federal Council for Science and Technology (FCST) is reported on page 112 of the February, 1975 issue of the NOTICES of the American Mathematical Society. In no case is the author personally responsible for paying the page charge, nor is acceptance of his paper for publication dependent upon payment of the page charge.

BACKLOG. 100 pages. Two-thirds of the papers currently being accepted by the editors will be published in 10–12 months.

SUBSCRIPTION INFORMATION. TRANSACTIONS OF THE AMERICAN MATHEMATICAL SOCIETY is published monthly. Subscription prices for Volumes 281–286 (1984) are \$445.00 list; \$223.00 member. A late charge of 10% of the subscription price will be imposed upon orders received from nonmembers after January 1 of the subscription year. Subscribers outside the United States and India must pay a postage surcharge of \$15.00; subscribers in India must pay a postage subcharge of \$28.00.

Editorial Information

To be published in the *Transactions*, a paper must be correct, new, nontrivial, and significant. Further, it must be well written and of interest to a substantial number of mathematicians. Piecemeal results, such as an inconclusive step toward an unproved major theorem or a minor variation on a known result, are in general not acceptable for publication. *Transactions* Editors shall solicit and encourage publication of worthy papers of length exceeding 10 published pages. Published pages are the same size as those generated in the style files provided for $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$.

As of July 8, 1993, the backlog for this journal was approximately 5 issues. This estimate is the result of dividing the number of manuscripts for this journal in the Providence office that have not yet gone to the printer on the above date by the average number of articles per issue over the previous twelve months, reduced by the number of issues published in four months (the time necessary for editing and composing a typical issue).

A Copyright Transfer Agreement is required before a paper will be published in this journal. By submitting a paper to this journal, authors certify that the manuscript has not been submitted to nor is it under consideration for publication by another journal, conference proceedings, or similar publication.

Information for Authors and Editors

The first page must consist of a *descriptive title*, followed by an *abstract* that summarizes the article in language suitable for workers in the general field (algebra, analysis, etc.). The *descriptive title* should be short, but informative; useless or vague phrases such as “some remarks about” or “concerning” should be avoided. The *abstract* should be at least one complete sentence, and at most 300 words. Included with the footnotes to the paper, there should be the 1991 *Mathematics Subject Classification* representing the primary and secondary subjects of the article. This may be followed by a list of *key words and phrases* describing the subject matter of the article and taken from it. A list of the numbers may be found in the annual index of *Mathematical Reviews*, published with the December issue starting in 1990, as well as from the electronic service e-MATH [telnet e-MATH.ams.org (or telnet 130.44.1.100). Login and password are e-math]. For journal abbreviations used in bibliographies, see the list of serials in the latest *Mathematical Reviews* annual index. When the manuscript is submitted, authors should supply the editor with electronic addresses if available. These will be printed after the postal address at the end of each article.

Two copies of the paper should be sent directly to the appropriate Editor and the author should keep one copy.

Electronically prepared manuscripts. The AMS encourages submission of electronically prepared manuscripts in $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$ because properly prepared electronic manuscripts save the author proofreading time and move more quickly through the production process. To this end, the Society has prepared “preprint” style files, specifically the amsppt style of $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}\mathcal{E}\mathcal{X}$ and the amsart style of $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}\mathcal{A}\mathcal{T}\mathcal{E}\mathcal{X}$, which will simplify the work of authors and of the production staff. Those authors who make use of these style files from the

beginning of the writing process will further reduce their own effort. Electronically submitted manuscripts prepared in plain $\text{T}_{\text{E}}\text{X}$ or $\text{L}^{\text{A}}\text{T}_{\text{E}}\text{X}$ do not mesh properly with the AMS production systems and cannot, therefore, realize the same kind of expedited processing. Users of plain $\text{T}_{\text{E}}\text{X}$ should have little difficulty learning $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}_{\text{E}}\text{X}$, and $\text{L}^{\text{A}}\text{T}_{\text{E}}\text{X}$ users will find that $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}^{\text{A}}\text{T}_{\text{E}}\text{X}$ is the same as $\text{L}^{\text{A}}\text{T}_{\text{E}}\text{X}$ with additional commands to simplify the typesetting of mathematics.

Guidelines for Preparing Electronic Manuscripts provides additional assistance and is available for use with either $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}_{\text{E}}\text{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}^{\text{A}}\text{T}_{\text{E}}\text{X}$. Authors with FTP access may obtain *Guidelines* from the Society's Internet node e-MATH.ams.org (130.44.1.100). For those without FTP access *Guidelines* can be obtained free of charge from the e-mail address guide-elec@math.ams.org (Internet) or from the Publications Department, American Mathematical Society, P.O. Box 6248, Providence, RI 02940-6248. When requesting *Guidelines*, please specify which version you want.

At the time of submission, authors should indicate if the paper has been prepared using $\mathcal{A}\mathcal{M}\mathcal{S}\text{-T}_{\text{E}}\text{X}$ or $\mathcal{A}\mathcal{M}\mathcal{S}\text{-L}^{\text{A}}\text{T}_{\text{E}}\text{X}$. The *Manual for Authors of Mathematical Papers* should be consulted for symbols and style conventions. The *Manual* may be obtained free of charge from the e-mail address cust-serv@math.ams.org or from the Customer Services Department, American Mathematical Society, P.O. Box 6248, Providence, RI 02940-6248. The Providence office should be supplied with a manuscript that corresponds to the electronic file being submitted.

Electronic manuscripts should be sent to the Providence office immediately after the paper has been accepted for publication. They can be sent via e-mail to pub-submit@math.ams.org (Internet) or on diskettes to the Publications Department address listed above. When submitting electronic manuscripts please be sure to include a message indicating in which publication the paper has been accepted. No corrections will be accepted electronically. Authors must mark their changes on their proof copies and return them to the Providence office. Authors and editors are encouraged to make the necessary submissions of electronically prepared manuscripts and proof copies in a timely fashion.
