On p. 527, formula 4.224(11) is incorrect for the cases $a^{2}<1$ and $a^{2}>1$. When $a>0$, the common value of the integrals $\int_{0}^{\pi / 2} \ln (1+a \sin x)^{2} d x$ and
$\int_{0}^{\pi / 2} \ln (1+a \cos x)^{2} d x$ can be written as

$$

where $G$ is Catalan's constant, $b=(1-a) /(1+a)$, and

Editorial note: Alternatively, when $a^{2} \leqq 1$, the value of these integrals can be expressed as $\pi \ln \left(1+\left(1-a^{2}\right)^{1 / 2}\right) / 2-2 \sin ^{-1} a \ln \left(1+\left(1-a^{2}\right)^{1 / 2}\right) / a+4 \mathrm{Cl}_{2}\left(\sin ^{-1} a\right)-\mathrm{Cl}_{2}\left(2 \sin ^{-1} a\right)$, where $\mathrm{Cl}_{2}(x)$ is Clausen's integral. When $a \geqq 1$, the value is $\pi \ln (a / 2)+4 \mathrm{Cl}_{2}\left(\sin ^{-1} 1 / a\right)-\mathrm{Cl}_{2}\left(2 \sin ^{-1} 1 / a\right)$.
