It contains some of the officially invited addresses presented before the Society, reviews of advanced mathematical books, research problems and a department of research announcements.

Proceedings of the American Mathematical Society

This journal is devoted entirely to research in pure and applied mathematics, and is devoted principally to the publication of original papers of moderate length. A department called SHORTER NOTES was established in 1961. The purpose of this department is to publish very short papers (maximum length, 1 printed page) of an unusually elegant and polished character, for which there is normally no other outlet. The definitive new proof of an important and long-known theorem, an illuminating new fact, or an interesting lemma used for proof of a theorem in a different field are examples of subjects suitable for publication in this department.

Articles for insertion in the PROCEEDINGS should be typewritten, double spaced. The maximum length of an acceptable paper is 8 printed pages. (A page of the PROCEEDINGS contains an average of 400 words; a typewritten page contains an average of 300 words. A rough rule of thumb, accordingly, is that under 10 typewritten pages is probably within the allowed limit, but over 11 typewritten pages is probably not.) The greatest possible care should be taken in preparing the manuscript and if necessary The Manual for Authors published by the Society should be consulted. The authors should keep a complete copy.

Papers in algebra and number theory should be sent to ARTHUR P. BUCK, or FRITZ JOHN, Courant Institute of Mathematical Sciences, New York University, 251 Mercer Street, New York, New York 10002; in geometry and topology to ELDON DYER, Department of Mathematics, Columbia University, New York, New York; in other branches of analysis, applied mathematics, and all other fields to W. H. J. FUCHS, White Hall, Cornell University, Ithaca, New York 14850 or FRITZ JOHN. All other communications to the editors should be addressed to the Managing Editor, R. C. BUCK. Inquiries from authors regarding reprints and changes of address for mailing galley proof should be sent to the Editorial Department, American Mathematical Society, P. O.
